GENERAL REQUIREMENTS

- FBN Member Account
- For Ontario purchases, customers must have a valid applicator license or certified farmer documentation on file with FBN to purchase restricted and commercial pest control products
- Signed Master Distribution Agreement (MDA) or other applicable agreement to terms and conditions of sale
- Purchase must be made between Oct 1, 2025 - Sept 30, 2026 to qualify for Membership perks

FULFILLMENT

- Discount or store credit will automatically apply in cart when the customer meets the purchase minimum of qualified products
- Store Credit will be added after the conclusion of the calendar month. All store credit expires September 30, 2026. No store credit will be given for September purchases.
