# **CONTROLLING WORKPLACE HAZARDS**

There are risks included with using herbicides and other chemicals. Applicators should always read the label which provides information on the proper application methods and other safety details.

Controlling exposures to chemical hazards and toxic substances is the fundamental method of protecting workers. A hierarchy of controls is used as a means of determining how to implement feasible and effective controls.

Engineering and work practice controls must be the primary way to reduce employee exposure to toxic chemicals. Respiratory protection is required to be used when engineering or work practice controls are infeasible or while they are being implemented.



Where possible, elimination or substitution is the most desirable followed by engineering controls. Administrative or work practice controls may be appropriate in some cases where engineering controls cannot be implemented or when different procedures are needed after implementation of the new engineering controls. Personal protection equipment is the least desirable, but may still be effective.

Administrative and Work Practice Controls (establish efficient processes or procedures)	<ul> <li>Rotate job assignments.</li> <li>Adjust work schedules so that workers are not overexposed to a hazardous chemical.</li> </ul>
<b>Personal Protective Equipment</b> (use protection to reduce exposure to risk factors)	<ul> <li>Use chemical protective clothing.</li> <li>Wear respiratory protection. [See the Respiratory Protection Safety and Health Topics page]</li> <li>Use gloves.</li> <li>Wear eye protection.</li> </ul>



# MIXING ORDER MATTERS

For herbicide applications mixed with water, remember the WAMLEGS acronym regarding mixing order. Begin by filling the spray tank with about half of the water required for the total spray job, and begin agitation.



Finally, add water to the required levels and continue agitation so that the tank mix is ready for spraying. *Always remember to read and follow label instructions.*
