















MEMBERSHIP TIER QUALIFICATION

- **Member:** Any *FBN* Member who purchased less than \$20,000 in the prior year period defined as October 1, 2024 thru September 30, 2025, or who does so in the period defined as October 1, 2025 thru September 30, 2026.
- **Gold Member:** Any *FBN* Member who purchased between \$20,000 and \$39,999, and included at least four (4) unique products at \$1,000 each in the prior year period defined as October 1, 2024 thru September 30, 2025, or who does so in the period defined as October 1, 2025 thru September 30, 2026.
- **Platinum Member:** Any *FBN* Member who purchased \$40,000 or more, and included at least six (6) unique products at \$1,000 each in the prior year period defined as October 1, 2024 thru September 30, 2025, or who does so in the period defined as October 1, 2025 thru September 30, 2026.

BENEFITS

- **Early-Bird Deals** include exclusive access to special promotions and discounts throughout the year including, but not limited to Cyber Days. Product eligibility will be determined for each individual promotional period.
- **Exclusive Pricing** will begin on or around January 6, 2026 and provide differentiated pricing on select products available to members based on their membership tier status at the time of purchase. Prices will be published in the *FBN* store.
- **Store Credit** for all qualifying purchases based on tier status will be tracked and awarded on a monthly basis. Credits earned will be calculated and posted to accounts during the first week of every month for purchases made in the previous month. All credits expire on September 30, 2026. Seed and Bulk Fertilizer purchases do not qualify for store credit.
